THIS CAUSE came before the court upon a Motion for Unaffiliated Creditors for Partial Relief From Injunction Orders and the court being fully advised in the premises now finds there is no legal basis to grant the requested relief to non-parties who have not been brought into or intervened in the cause. Furthermore, the specifically cited provisions of the injunction dealing with the Receivers' exclusive right to file a voluntary petition under Title 11 of the United States Code purports to prohibit the exercise of said right by those who otherwise might be vested with authority over corporate governance, such as officers, directors or shareholders of the Receivership Entities. Thus actual unaffiliated creditors who had merely arms length debtor-
